These are products that have been validated for compliance with country of origin requirements set forth in the Trade Agreements Act (TAA). These products are also subject to these controls to enhance supply chain security:

- USG products are specially configured to receive software updates only from designated servers located in the US.
- Technical support for USG products sold to Federal customers that are covered by a FortiCare maintenance plan are provided by US citizens working in a dedicated Technology Assistance Center located in the US.

All USG products are assigned a SKU that ends in –USG.
