



Promotion Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. Void where prohibited. All international, foreign, federal, state, and local laws and regulations apply. This promotion is in no way sponsored, endorsed, administered by, or associated with Twitter. Promotion Period: This Promotion starts at 9:30am (PST) on February 19th, 2018 and ends at 4:00pm (PST) on March 8th, 2018.

Eligibility: This Promotion has two parts. There will be three weekly promotions (“Weekly Promotions”) run on Twitter at @FortinetHealth. The final promotion will be held at the HIMSS 2018 Annual Conference and Exhibition (“Conference Promotion”). The Weekly Promotions are open only to a natural person who is at least the age of majority and a legal resident of the United States for the duration of the Promotion. Entry Period and How to Enter:
